Steve Bennett Assemblymember, 38th District



Assemblymember Steve Bennett was elected to the Assembly in November 2020 and represents the 38th district that includes the western part of Ventura County. He currently serves as Chair of Budget Subcommittee 4: Climate Crisis, Resources, Energy, and Transportation, and the Chair of the Select Committee on Building a Zero-Carbon Hydrogen Economy.

Born and raised in the Midwest, Steve developed a strong sense of community responsibility. After graduating from Brown University with an Honors Degree in Economics, Steve served his community as a high school Economics and American History teacher for over 20 years. At the same time, he advanced solutions to community problems of urban sprawl, money corrupting politics, and problems encountered by disadvantaged communities.

He was elected to the Ventura City Council in 1993 and served until 1997. There he co-authored the Save Open Space and Agricultural Resources (SOAR) initiatives that have made Ventura County a national leader in land-use planning. SOAR slows urban sprawl by requiring a vote of the citizens before greenbelt areas outside of the cities can be rezoned for development. During his time on the city council, he also authored one of the State's toughest campaign finance reform laws; as he fought to decrease the role of money in politics.

From 2000 to 2020, Assemblymember Bennett served his community as a Ventura County Supervisor. He first brought fiscally responsible policies to county government. He then led efforts to improve conditions for the disadvantaged and the voiceless. He co-authored a first of its kind Farmworker Resource Program that has dramatically improved the county's assistance to this vulnerable and valued population. He beat back opposition to the creation of Ventura's first municipal homeless shelter.

Steve has a particular passion for supporting the foster children of Ventura County and the 11,000 seniors residing in hundreds of nursing facilities. He spent 20 years leading the Board in efforts to improve conditions for foster children and ensure that the thousands of seniors who have outlived their friends and family receive a weekly visit by an Ombudsman solely focused on their welfare in the facility.

Steve launched his bid for the Assembly with a recognition that the window to effectively address climate change is rapidly closing. His first climate change efforts focus on improving storage capacity of renewable energy which is an essential step to achieving the goal of 100% renewable energy.

Steve and his wife Leslie share a passion for education. Leslie spent three decades as a high school Spanish teacher. For the past 14 years, they have shared their home with an immigrant family from Mexico. The experience of their adoptive family has led to a desire to leave a better world for those trapped by growing income inequality. Improved educational options, access to good medical care, and affordable housing are essential to doing that and a focus of Steve's service in the Assembly.

Monique Limón Senator, 19th District



Senator Monique Limón was elected to the California State Senate in November 2020 and represents the 19th Senate District, which includes all of Santa Barbara County and more than 60% of Ventura County. Senator Limón served as the Assemblymember from 2016 to 2020. Born and raised in the 19th Senate District, Monique has worked as an educator, leader, and an advocate for causes advancing the quality of life in her community.

For Monique, education has always been a priority. She received her undergraduate degree from UC Berkeley and a Master's Degree from Columbia University. Prior to being elected to the California State Legislature, Monique served on the Santa Barbara Unified School Board and spent fourteen years working in higher education at UC Santa Barbara and Santa Barbara City College.

Monique worked with nonprofits in the community including the Santa Barbara Foundation, New Beginnings Counseling Center, the McCune Foundation, Leading from Within, and the Community Engagement Committee for the Granada Theatre.

In the Senate, Monique currently serves as Chair of the Senate Select Committee on the Nonprofit Sector where she has worked to uplift the work of nonprofits across California and ensure they have the resources necessary to serve their communities.

While in the Assembly she advocated for the creation of the first ever Select Committee on the Nonprofit Sector. As Chair of the Select Committee on the Nonprofit Sector, she worked to bring awareness to the impact nonprofits have in our economy. In 2018 she authored a bill to establish a centralized database for funding opportunities available to nonprofits that is now an important tool for nonprofits across the state. After its creation she was subsequently named Chair of the Assembly Select Committee where she held committee hearings to explore the importance of the connections between state government and nonprofits, and expanded the California Annual Nonprofits Day into an ongoing tradition statewide.

Dr. Morales leads VCOE, which employs nearly 1,000 people and provides teacher training and administrative support services to all the County's 20 school districts. VCOE also operates schools for students with special needs, at-promise students and provides career education for students countywide.

Dr. Morales received his Doctor of Education degree from UCLA and his master's and bachelor's degrees from Loyola Marymount University. Dr. Morales is currently serving as the Chair of the Board of Directors of FCMAT (Fiscal Crisis Management and Assistance Team) and an Advisory Board Member for the California Collaborative for Educational Excellence. Linda Braunschweiger Chief Executive Officer, Housing Trust Fund Ventura County



Ms. Braunschweiger has spent over thirty five years in finance, affordable housing development, non-profit management, and business. She spent many years in public affairs and lobbying at the federal, state, and local levels. Ms. Braunschweiger launched Braunschweiger & Associates (B&A) in 1999 assisting clients with affordable housing policy strategies and financing, strategic planning, and nonprofit management.

In 2008, Ms. Braunschweiger was selected as the founding contract CEO, becoming a full time employee in 2017, of the Housing Trust Fund Ventura County. In her role as CEO, she helped orchestrate the formation of HTFVC, raised over \$40M in public, private and charitable funds, and produced \$40M in short term loans of which the majority have been repaid allowing funds to generate new loans, producing 1766 new workforce affordable housing units. Under her leadership, HTFVC became a certified Community Development Financial Institution (CDFI) at the Federal and State level.

Ms. Braunschweiger spearheaded in 2020 the creation of the Housing Land Trust Ventura County, a supporting nonprofit of HTFVC. The Land Trust's mission is to preserve donated land for the development of affordable housing in perpetuity. HLTVC's first donated piece of land is in the City of Oxnard with 110 bed homeless shelter and 55 affordable rental units under construction. In Nov 2022, the Land Trust received a second donation of land, from the City of Thousand Oaks, for 78 for-sale affordable townhomes.

In 2024, Housing Trust Fund VC was named Nonprofit of the Year by Assemblymember Steve Bennett. In 2020/2021, 2022, 2023, and 2024, Ms. Braunschweiger was selected as one of the Pacific Coast Business Times "Top 50 Women in Business" from San Luis Obispo, Santa Barbara, and Ventura Counties. In 2022, she received the Rodney E. Fernandez Excellence in Visionary Leadership Award from the Ventura County Community Development Corporation. Ms. Braunschweiger has a BA in Speech Communications and Industrial Psychology and an MBA with a focus in Public Policy.
